**PURPOSE:**

This Second Addendum (“Second Addendum”) is being issued subsequent to and as part of the issuance of the City of Rancho Mirage Request for Proposals for Wireless Network Installation for Library, Amphitheater and Construction Management Office, dated May 31, 2016 (“RFP”) and subsequent Addendum to RFP issued June 20, 2016 (“First Addendum”), because the City is deleting the Mandatory Pre-Proposal Meeting requirement in the RFP.

**GENERAL INSTRUCTIONS:**

This Second Addendum constitutes an integral part of the RFP and shall be read in conjunction with the RFP and First Addendum. The following is hereby deleted from the RFP, thereby providing an opportunity for all qualified prospective bidders to submit a bid, whether or not those companies or persons attended the June 10, 2016 meeting:

**MANDATORY PRE-PROPOSAL MEETING:**

A mandatory pre-proposal meeting will be conducted at 9:00 A.M., on JUNE 10, 2016. The meeting will be held in the Barker Conference Room at the City of Rancho Mirage Public Library, 71-100 Highway 111, Rancho Mirage, CA, 92270. Immediately following the pre-proposal meeting, City staff will accompany interested parties wishing to tour the City facilities identified in the Scope of Services portion of this RFP. This will be the only time that tours of such City facilities will be conducted. No pictures or videos will be allowed. NOTE: Picture identification will be required of all attendees.
