All respondents shall acknowledge receipt of this Addendum by signing the form that is attached hereto as Exhibit “A.” All terms capitalized herein shall have the same meaning ascribed to them in the Notice Inviting Informal Bids.

QUESTIONS AND ANSWERS:

Question 1. We believe that the subject project can be constructed and successfully performed by a General Building contractor.

Please confirm if the City will be willing to amend their bid documents to allow B license contractors to submit a competitive bid for City of Rancho Mirage.

Answer: Class B General Building Contractor is also eligible to propose on this project.
